We in Amateur Radio have a wonderful opportunity to provide a public service. In fact, we will be very accountable to top officials during the Top Off drill, a major DHS exercise involving CT, and NJ. WE NEED YOUR HELP! Even if you are not an experienced ARES member, you too can help out because everyone will be working in teams. If you are considering signing up to help, DO IT TODAY please because you will have to be credentialed in order to participate.

The process goes like this:

(1) Register (see info below). (2) You will be given an assignment that you're comfortable doing. (3) You will be sent by email important information.

On the day you report, you will be briefed and then sent off to your tasks. SEC Chuck AB1CR is our incident commander for this event--he is the person in charge of our Amateur Radio effort. He has asked me to post the following.

When available: April 4 - April 5 -April 6 - April 7 - April 8

(Note: If you say are available from 6:00 am to midnight, rest assured we will not give you an 18 hour shift. It would be helpful if you can tell us the maximum shift duration you are comfortable with - if that is longer than your availability.)

Other information:

The four types of positions are:

1 - Permanent Fixed locations where the radios and antennas are already setup and we just need operators.

2 - Temporary Fixed Locations where the communicator will need to bring at least a 25 watt radio, power supply, backup battery and portable antenna with mast.

3 - Shadow stations who will stay with key people and will need a handheld radio and plenty of battery (either AA battery backup or small Jell Cell battery backup).

4 - Mobile in Red Cross or other vehicles will need at least a 25 watt radio, mag mount, and the ability to take power from a cigarette lighter jack or straight from the vehicle battery.

What do we really need now? We will be running three shifts each day (as far as we know.) It is a drill and we do not have full details. Currently it looks like we will be needed Monday through Wednesday only.

## **Monthly Connecticut Section News Summary – cont'd**

We need people at stationary positions like Net Control, OEM Offices, and a listening post/backup net control at staging area. Probably still need one or two more people on each shift. We need people at Temporary Fixed locations: Currently need about five people on each shift. We need people to shadow key Red Cross people. Currently need about three people on each shift. We need people to provide communications for the Red Cross vehicles. Currently need about 10 people per shift.

The shifts will start early in the morning, probably 6:00 or 7:00 AM and go through 6:00 PM or 7:00 PM The "evening" shift will start about 5:00 PM and go through about midnight The "night" shift will start about 11:00 PM and go through about 7:00 or 8:00 AM (Note that individual position assignments may vary slightly from these times, but this gives you an idea what to expect.) Please note that these shifts overlap as we have to get credentials, exchange people without leaving positions uncovered, etc.

SB 92.--I am sorry to report that for now, it's dead. No motion to draft SB-92 as a bill is on the agenda for today's (Thursday) meeting of the Energy and Technology Committee. Apparently the issues I mentioned last month were not resolved even by a substantial amount of quality, technical testimony on the subjects of antenna height, RFI and property value that was submitted after the hearing. Know well that your SGL Mike, K1MK and many of us on the leadership team put in hours of work and we're going to do it again next year with a different emphasis. We will begin to plan that effort in June or early July. Again, thanks to everyone who helped out in any way--volunteers and ARRL staff--we all worked hard. On the positive side, three bills were introduced and in addition to their three sponsors we collected 12 co-sponsors. That's more sponsors and co-sponsors than many pieces of PRB-1 legislation that have been passed in other states garnered. So folks, we'll be doing this important legislative effort again.
