## ***Mountain Bike Race***

On Sunday, April 12<sup>th</sup>, members of the ICRC assisted members of the Central Connecticut ARC with radio communications for the 2005 Fat Tire Classic mountain bike race held at the Winding Trails Recreation Area in Farmington, CT. Operators with mobile set-ups positioned their vehicles at strategic locations along the race course to record the numbers of the racers as they passed by and also to act as safety operators. The group successfully dealt with several situations, ranging from the minor to the more severe. A small child was lost on the course. After being located by other bike riders, she was brought to one of our check-points where she was picked up by race officials and returned to her worried mother. The position of another racer who was reported to have a cut on her leg was monitored by the group. (She ended up needing several stitches from the paramedics at the end of the race.) Another racer was reported to have crashed in a densely wooded part of the course and sustained a broken ankle. The operator from the nearest check-point set out on foot with an HT to locate her and radio her location to the paramedics, who extracted her from the woods and brought her to a waiting ambulance for transportation to a local hospital. Never a dull moment! Participating from the ICRC were Rick - N1JGR, Chuck – K1DFS, Dan – WA1PAT, Pete – KB1KZC, and John – KA1WVM. Participating from the Central CT ARC were Rose – KB1DMW, Richard – KB1DMX, and our own Al – N1JWF, who also served as Net Control Operator. A good time was had by all! As mentioned earlier, we will be doing this again for the September 25<sup>th</sup> race. This time we had just enough operators to cover the major positions, but for next time we could use several more operators to cover additional positions. Come on out and join the fun!

## **Amateur Radio Emergency Communication Courses**

Greetings from ARRL HQ.

As you have likely heard in recent months, ARRL is now well into the final year of the grant-sponsored Amateur Radio Emergency Communication Courses. With this grant, the \$45 registration fee paid upon enrollment will be reimbursed after successful completion of the course. At this time, it's only available to ARRL members.

Students need to enroll during the May or the June registration periods to be eligible for reimbursement under the Corporation for National and Community Service (CNCS) grant. That also means that students will need to have completed their course work, and their Mentor/Instructor must upgrade their student status at the ARRL Mentor/Instructor Site to "Passed" by August 31, 2005, to qualify for reimbursement from the CNCS grant.

Registration for the ARRL Amateur Radio Emergency Communications Level I on-line course (EC-001) opens Monday, May 2, 2005, at 12:01 AM EDT. Level II (EC-002) registration opens the same time on the following Monday, May 9. Level III (EC-003) will also open at the same time, but on Monday, May 16. ARRL members will be able to register for the remaining on-line course seats at the ARRL EXPO area of the ARRL National Convention at Dayton. Applications and payment via credit card, check or cash will be accepted there.

Registration by mail is also an option. Make the check or money order out to ARRL, and mail it to 225 Main Street, Newington, CT 06111.

Please mark the envelope "ATTN: CCE." In the comment segment of the check or money order, write "CCE EC-00# Registration." # means the course number such as 1, 2, or 3.

Include your call sign, current mailing address, preferred e-mail address, age, gender and veteran status, and complete telephone number with your check or money order. Missing information will cause delays in registration, and there is no time left for delays.

## **Monthly Connecticut Section News Summary**

Two clubs are to be congratulated: The Southern Berkshire ARC on its 40<sup>th</sup> year as an ARRL affiliated club and The Southington ARC on its 50th year! Certificates will be presented to both clubs in the near future.

Spring is here--we know this for sure when the Southington Ham Fest comes around! Don't forget--it's this coming Sunday at Southington High School. So do that Spring cleaning and bring your goodies to the flea market. ARES members will be able to greet each other and swap tales about their experiences at Top Off at the annual ARES meeting Sunday 11:00 a.m.

And now some words from our SEC Chuck, AB1CR: I would like to take this opportunity to say Thank You to all of you who made ARES such a successful presence at TOPOFF III! By my calculations, we provided over TWO THOUSAND hours of service to the Red Cross and Connecticut Office of Emergency Management. This time was, by and large, well spent in providing service to our served agencies. Hundreds of tactical messages were handled, as well as some formal message traffic. Packet was used to send reports from the Tactical NCS to the CT OEM Area 4 office, to exchange messages between CT OEM Rocky Hill (which handles messages for OEM Headquarters in Hartford) and the ARES Marshaling Area. Packet and HF (3.965) were used to send some of the formal NTS traffic. APRS was used to track the shuttle vans that were too small to take up capacity with an actual operator. We used a significant number of technologies to make all this happen.

We worked through a number of difficult issues, ranging from the TrackNet repeater going down (we simply switched to the UHF side of that system and kept going) to difficulties mounting radios in ERVs, to issues getting appropriate power to radios, and the ever-present "where do I put my magnetic mount antenna on this fiberglass vehicle? (Answer: Use one of the steel plates provided by K1DAV and GAFFERS TAPE - no duct tape please - to tape it to the vehicle and remove it without damaging the vehicle). There are a significant number of people who deserve special thanks, and anytime one makes a list of this nature some deserving person is sure to be left out. I hope I have recognized the key players, but if I missed someone, please let me know! Hank, K1WTS, DEC for Area 4 - who not only kept things together throughout the planning and the drill, but also arranged for the incredible resource of the Chesterfield Fire Station to serve as our ARES Marshaling area. Wayne - N1CLV - for proving to be the smoothest Net Control Station many of us had ever heard, for setting up the Coast Guard Academy Amateur Radio Station to serve as a relay for the Coast Guard Kitchen (an RF black hole), for making the Recon Rally fun and productive, and for an incredible number of hours spent organizing and preparing for the event. Betsey - K1EIC - Our Section Manager who spent days at the ARES Marshaling Area, handling Net Control duties, handling NTS traffic, and serving as our media liaison. Rod - N1FNE - for setting up the system that allowed an operator in the middle of a hotel to hit the repeater without difficulty, for handling too many technical issues to mention, for taking the overnight shift at Unified Command (and serving as Net Control during that time so the rest of us in the Marshaling Center could get some sleep), and for proving that a positive attitude always wins. Brian - K1BRF - for spending an enormous number of hours before and during Top Off working directly with the Red Cross attending to the many details necessary for our proper credentialing and participation. There were several days during which Brian left his home before most of us woke up to represent us at critical planning meetings. Bill - W1WJB - for inspiring his team and for the "Gang-of-Four" who took the reigns in Area 1 since W1WJB was away on ARRL business during the actual event. Art - K1WMO for his steadfast support and for setting up an opportunity to address his local Ham Radio club where seven people signed up that very night! Mac - W1FYM for all of his work at CT OEM Rocky Hill and OEM Hartford. For all his efforts to ensure a good packet system, Dave - K1DAV for providing the type of leadership that

many of organizations can only dream of. For providing the metal plates for the magnetic mount antennas, for leading an ARES MAT (ARES Mutual Assistance Team) and for providing countless hours of service.
