#### Governor Rell Names June 19-26 as Amateur Radio Week in Connecticut

#### Ham Radio Station on State Capitol Lawn

In an official statement (text is below) recognizing the contributions to the public welfare by Connecticut's radio "hams Governor Rell took note of their nationwide annual Field Day encampment. She recognized those hams who are organized as weather spotters (SKYWARN) for the US Weather Bureau and she noted the work of the Amateur Radio Emergency Service (ARES) during Operation TOPOFF3.

The Connecticut Legislature also issued a Citation in observance of Amateur Radio Week.

Field Day is a live field operation, also a demonstration of Amateur Radio, and an exercise in skills and readiness. Additionally it is a nationwide contest between clubs to attain the highest number of contacts with other stations.

Persons who have never seen an Amateur Radio Field Day site in operation will have an opportunity to do so on the grounds of the State Capitol in Hartford, where TWO field day stations will be in operation from 9 am to 4 pm Saturday.

Throughout Connecticut and the nation many Amateur Radio Field Day sites will be open to visitors.

#### **FOR EXAMPLE:**

(In Newington, the public is invited to a Field Day Opening ceremony on Cedar Mountain at the North end of Russell Road in Newington at 3 PM on Saturday June 26<sup>th</sup>.

This campout is operated by NARL, a regional Amateur radio society based in Newington with members from throughout the Capitol Region. NARL President is Ron Cady K1RKD of West Hartford. VP is Dan Miller of Bloomfield.

Signs will mark the location.

Newington Mayor Tom McBride will read a proclamation recognizing the contributions of Radio Amateurs.

State Rep. Sandy Nafis and State Senator Billy Ciotto will read the Governor's Official Field Day Statement and a Citation from the Legislature.)

WHEREAS, the year 2005 Ham Radio Field Day will take place on June 25-26, and is a 24 hour round-the-clock emergency exercise encampment and demonstration of the Radio Hams' skills and readiness of stand-alone powered equipment in fields, hillsides, and woodland clearings; now

The following was just received here from Steve Ewald, WV1X at ARRL Hq.-- Attention All Amateurs...

ARRL warns against spurious, virus-infected e-mails (Jun 16, 2005)--

Some ARRL members have recently reported receiving e-mail messages that purport to be from ARRL. These messages suggest that the recipient's account has been used to send "a large amount of unsolicited commercial e-mail," that their password has been changed or some other action was going to be taken regarding their arrl.net "account." The e-mail may be signed by "The ARRL Support team" or "The arrl.net team." Some messages also may show up as e-mail bounces from "Postmaster" or "Mail Administrator." These messages, which include a file attachment, are bogus. They do not originate from ARRL, and recipients of such messages should never attempt to open the attached file. Outside of routine correspondence, the ARRL only sends e-mail to members who specifically request mailings, such as W1AW bulletins and The ARRL Letter. Opening the attached file on one of these spurious messages could unleash a nasty computer virus. As a defense against these kinds of viruses, ARRL strongly recommends installing virus-protection software on all personal computers and updating virus definitions on a regular basis.
